**FINAL ORDER**

This matter comes before the Department of Highway Safety and Motor Vehicles for entry of a final order upon submission of the Order Closing File and Relinquishing Jurisdiction issued September 8, 2022, by the Honorable Todd P. Resavage, Administrative Law Judge of the Division of Administrative Hearings, based on Petitioner's Notice of Withdrawing Petition, filed September 8, 2022, copies of which are attached and incorporated by reference in this order.

Petitioner's protest having been withdrawn, the petition is **DISMISSED** and the case is **CLOSED**. The Department additionally takes notice that, on August 12, 2021, Respondent Club Car, LLC, notified the Department of the withdrawal of its application to establish Scott's Automotive & Golf Car Repair, Inc., as a dealership for the sale of Club Car low-speed vehicles (line-make CLUB), and such notice of withdrawal appeared in the Florida Administrative Register on September 6, 2022 (Vol. 48, No. 173, at p. 3606). If Respondents were subsequently to reapply for this franchise location, notice of a new application must be published in the Florida Administrative Register pursuant to § 320.642(1), Fla. Stat.

### **NOTICE OF RIGHT TO APPEAL**

A party adversely affected by this final order may seek judicial review as provided in § 120.68, Fla. Stat., and Fla. R. App. P. 9.190. Judicial review is initiated by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate district court of appeal. The notice of appeal must conform to the requirements of Fla. R. App. P. 9.110(d) and must be filed within thirty (30) days of rendition of this final order.

Filing with the Agency Clerk may be accomplished by U.S. mail, express overnight delivery, hand delivery, facsimile transmission, or electronic mail.
