**SPECIAL PERMIT FOR
PROPAGATION OF *CASUARINA CUNNINGHAMIANA***

This permit is issued to _____ owner/operator of _____ Florida Nursery

Florida.

This permit allows the holder to propagate *Casuarina cunninghamiana* plants from registered source trees as defined in Rule 5B-57.012, F.A.C. The terms, requirements and conditions of this permit are binding on the permit holder and enforceable by the Florida Department of Agriculture and Consumer Services (FDACS). Unless revoked, this permit is valid for one year following the date of issue.

General Conditions:

- (a) All *Casuarina cunninghamiana* plants must be vegetatively propagated from registered male source trees. All cuttings must be witnessed by a Division of Plant Industry (DPI) Representative.
- (b) An annual fee of \$50 must be paid for each registered source tree and each registered source tree must be labeled with a permanent tag that contains the source tree registration number assigned by the department. The source trees will be tagged by DPI.
- (c) Each plant propagated from the registered source tree must be labeled with an approved permanent tag that contains the source tree registration number. Obtaining tags is the responsibility of the Nursery.
- (d) Propagations from each registered source tree shall be maintained in nursery rows or on greenhouse benches so that each group can be identified as originating from an individual registered source tree. These trees must be kept separate from other nursery stock.
- (e) Source tree registration numbers of the parent plants must be documented on each invoice provided to the buyer.
- (f) Nurseries may only sell *Casuarina cunninghamiana* to a person with a Special Permit for *Casuarina cunninghamiana* Windbreaks. The nursery must include the buyers permit number on each invoice.
- (g) Copies of *Casuarina cunninghamiana* invoices must be maintained for 5 years and be made available to the department upon request.
- (h) Upon expiration of the Special Permit for Propagation of *Casuarina cunninghamiana* issued by the Department, all remaining propagations must be destroyed, sold or transferred to a nursery that has a current special permit for propagation for *Casuarina cunninghamiana*.

(i) The destruction or movement of any *Casuarina cunninghamiana* plants must be done under the direct supervision of the department.

(j) This permit is renewable annually. Application for renewal must be received by the Department at least 30 days prior to the expiration of the prior year permit.

This permit does not relieve the permit holder from liability for any damage to human health, the environment or property resulting from activities conducted under this permit.

By accepting this permit the permit holder acknowledges that in the event the *Casuarina cunninghamiana* propagated pursuant to this permit and any source trees must be destroyed, the permit holder is responsible for all costs of destruction.
