APPLICANT AGREES TO:

- Deal only in nursery stock that has been inspected and approved by the Division of Plant Industry (or imported in compliance with Florida laws) and accompanied by a valid inspection certificate (tag) as required by Chapter 581, Florida Statutes.
- Not knowingly sell or distribute nursery stock to individuals intending to resell or further distribute such stock within the State of Florida unless such individuals are registered with the Department as a nursery or nursery stock dealer.
- Not knowingly sell or distribute nursery stock for planting within 100 feet of a commercial citrus grove, a citrus nursery, or an approved nursery site, unless the stock is burrowing nematode-certified.
- Not bring or cause to be brought into the state any citrus plants or parts of citrus plants without a valid permit from the Director of the Division of Plant Industry.
- Furnish a list of all plant movements with full name and address of all purchases and consignees with a complete description of the stock in each movement, when requested.
- When requested to do so, return all inspection certificates (tags) on hand, including rubber stamps, to the Division of Plant Industry.
- Permit the entry of authorized representative of the Department for the purpose of inspecting plants or plant products for plant pests or noxious weeds.
