**Disposal Site**

No disposal site will be approved for dumping without a risk assessment of the dumpsite. As a part of the risk assessment, an inspector will conduct an initial survey of the property and obtain any information needed for the risk assessment, including but not limited to, the origin of material, how often dumping will occur, treatment of material, distances from other commercial and dooryard citrus, citrus nurseries, stock-dealers, presence of cattle, secure or locked location and route traveled. The site will be inspected on a weekly basis during the time of dumping activities occur. The permit holder must notify the local Citrus Health Response Program office three days prior to the commencement of dumping. This permit is issued and valid for one year from date of approval.

**General Conditions**

- 1) All citrus material must be transported in a conveyance that is enclosed or covered with a tarp that will prevent the loss of citrus waste or debris in transit or debris in transit as outlined in the Harvester/Hauler Compliance Agreement, FDACS-08359, Rev. 07/22.
- 2) All loads must move by either Limited Permit, FDACS-08156, Rev. 04/22, or by *Schedule 12, Citrus Waste/Debris Shipment Log*, Rev. April 2022.
- 3) All citrus material must be completely removed from conveyance prior to departing the disposal site and the conveyance, the equipment used, and personnel must be decontaminated in accordance with *Schedule 11, Approved Decontamination Products & Methods*, Rev. April 2022.
