## **INSTRUCTIONS:**

A valid Premises Identification Number (PIN) or a completed Application for Premises Registration, FDACS-09215, is required to issue USDA tags.

Complete a separate form, or set of forms, for each owner's cattle being tagged.

Groups of animals tagged with sequential numbers can be entered on multiple lines of the form as shown in the examples above.

List any other identification available in the "Other Identification" column. Official market backtags must be correlated to official ear tags.

If cattle are returning to premises of origin, input "return to premises of origin" in the Destination column.

If cattle are being sold through a livestock market, list the name of the market or, if known, list the buyer in the Destination column.

If cattle are being sold by private treaty, list buyer's name and address or their Premises Identification Number in the Destination column.

Records completed by a Tagging Site must be submitted to the Department within 7 days of application of the tags.
