## LP GAS EXAMINATION SCHEDULING INFORMATION

Appointments are required for persons sitting for all liquefied petroleum gas examinations. **NO WALK-INS FOR THE EXAMINATION WILL BE ACCEPTED.** To schedule an exam, you must:

1. Complete and sign the examination request form-**PRINT OR TYPE ONLY.**
2. Return the form to the Division of Consumer Services at the address indicated, along with the appropriate examination fee. (Make checks payable to "Florida Department of Agriculture and Consumer Services" or "FDACS").
3. **MASTER QUALIFIER EXAMINEES:** Must provide proof of previously passing the Category I LP Gas Dealer (0601) examination; must complete Master Qualifier Declaration of Eligibility statement (form FDACS-03527 Rev. 02/14) indicating status within the company.

Once the Division headquarters in Tallahassee has received the form and your fee, you will be contacted and advised of your examination date. Examination requests should be submitted at least two weeks in advance.

Examinations will be offered in Tallahassee Monday thru Friday beginning at 9 AM and continuing until completed in accordance with the below-indicated time frames. Examinations are also scheduled in Plantation depending upon the number of examinees and in Ocala during May and June only. Please indicate the examination site you prefer on the examination request form. These forms are available from the Bureau office. Your examination fee is **NON-REFUNDABLE**. If you do not appear at the scheduled time, your fee **will not** be refunded. Examination fees are not transferable. Except for the Master Qualifier Examination, all examinations are open book. Exams must be completed within the following times:

0601 - Category I Liquefied Petroleum Gas Dealer - 5 (five) hours  
0604 - Category II LP Gas Dispensing Unit Operator - 2 (two) hours  
0605 - Category IV LP Gas Dispenser and Recreational Vehicle Servicer - 3 (three) hours  
0803 - Installer A - 4 (four) hours  
0408 - Installer C - 3 (three) hours  
Master Qualifier Examination – 1 (one) hour (NO BOOKS)  
**ALL OTHER EXAMINATIONS ARE LIMITED TO TWO HOURS**
