**LEGAL RIGHTS AND MAILING INSTRUCTIONS**

The legal options available to you after you have been issued a citation are as follows:

- a) You may **DISPUTE** the facts alleged in this citation and elect to have the case formally prosecuted. In that case, you must check the appropriate box and return the original or a copy of the citation within 30 days of the date you were served. An Administrative Complaint will be filed thereafter and served upon you. If the Department prevails at the hearing, you may be required to pay a fine, as well as any additional attorney's fees, costs of investigation, or administrative costs. Prosecution will be in accordance with Chapters 120 and 472, Florida Statutes. ***If you elect to have this matter prosecuted, send the citation to the following address:***

**NOTE: If you do not return the citation with your choice properly marked within 30 days of the date you were served, you will have waived your right to dispute the charges against you, and the citation will automatically become a final order.** Failure to pay a citation fine within 30 days after the citation has become a final order constitutes an additional violation and may subject you to further disciplinary action.

The postmark on the envelope mailed by you or a delivery service to the proper address, or hand-delivered document hand-stamped by the Department, constitutes **proof of timeliness**. You may wish to mail the citation by certified mail, return receipt requested, as your returned receipt also constitutes proof of your compliance with the time requirements.

- b) You may **PAY** the fine (and costs, if applicable) specified on the citation by mailing a copy of the citation and full payment of the fine to the Department within 90 days of the date the citation is served. After you have paid the citation fine, the case will be closed with no further action taken by the Department. ***If you elect this option, send the citation and payment to the following address:***

**NOTICE OF APPELLATE RIGHTS**

**YOU ARE HEREBY NOTIFIED, pursuant to Sections 120.569(1) and 120.68, Florida Statutes, that you may appeal a citation that becomes a Final Order by filing, within 30 days of the Order date, a Notice of Appeal and appropriate filing with the Clerk of the Department of Agriculture and Consumer Services, and a copy of the notice, accompanied by the filing fees prescribed by law, with the clerk of the appropriate District Court of Appeal within thirty days of rendition of this Order, in accordance with Rule 9.110, Florida Rules of Appellate Procedure, and Section 120.68, Florida Statutes.**
